Thank you for your interest in attaining a CSIA equivalency. Enclosed, you will find the information you need to complete your application and make the first steps towards a CSIA affiliation and equivalency.

In order to be considered for a CSIA equivalency, all foreign instructors must first become **CSIA Foreign Affiliate Members**. For an annual fee of \$125.00 CDN plus applicable taxes, we would provide you with the following introductory package and benefits:

- ✓ The right to have your status considered for equivalency
- ✓ CSIA History booklet
- ✓ Affiliate membership card
- ✓ CSIA manual
- ✓ DVD on Canadian Technique and teaching methodology
- ✓ Participation at a PDP session
- ✓ Ski Pro Magazine (while living in Canada)
- ✓ Communication
- ✓ E-mail broadcast
- ✓ Insured as a ski instructor while teaching in Canada (Liability insurance only)

When you submit your application, you must include the following information: 1) *Completed application form (enclosed)*, 2) *a copy of your current instructor's certificate or membership card from the national ski instructor's body of your country*, 3) *your payment either by credit card or money order*.

Your qualifications will be taken into consideration when your application is being reviewed. Once you are granted equivalency, you may instruct skiing in Canada as a *CSIA Foreign Affiliate Member*. You may not be considered as a **Regular Member** until you have taken an appropriate CSIA certification course. Once you have successfully completed this course, your status will be changed to **Regular Member**. Taking the next level of CSIA certification is beneficial for all members. By successfully completing these advanced courses for CSIA certification, you can obtain international recognition and increased standing as a ski instructor.

Every year that your membership dues are fulfilled, you will retain the right, as a Foreign Affiliate Member or as a Regular Member, to participate in PDPs, continue to receive Ski Pro (while living in Canada), E-BLAST and other CSIA communications.

If you would like to have Ski Pro delivered to your home overseas, we would be more than happy to do so. For overseas members, please include a payment of \$12.50 (Canadian) for two issues (fall 2006 & winter 2007), or \$6.25 CDN for the winter issue only. If you reside in the United States, you may receive SKI PRO for \$6.50 CDN for two issues or \$3.25 for the winter one. The fall edition will be published mid October 2006 and the winter edition will be published end of January 2007.
